If the title was issued prior to the 11-89 edition, a separate odometer statement must be attached. If dealer is applying for title in the dealer's name, and an active lien (recorded less than six years prior to the current date or eight years prior to the current date for a truck tractor or trailer weighing in excess of 10,000 pounds or 30 years in the case of a mobile home or emergency vehicle) exists on the vehicle record, the dealer must contact the lienholder for completion of Section C. Lienholder's signature must be notarized.
